#### SECTION A: CONFIRMATIONS.

Item No. 28.01: Confirmation of the Minutes of the 27<sup>th</sup> Meeting of the Board of Governors (BoG) of CIT Kokrajhar held on 20<sup>th</sup> of January 2023 in AICTE Campus, Nelson Marg, New Delhi.

Item No. 28.07: Permission for promotion for eligible teaching employees of CIT Kokrajhar.

It was apprised to the Members that some of the faculty members were now eligible for academic grade pay upgradations as per applicable norms. Subsequent to the resolutions of the minutes of the 22<sup>nd</sup>, 24<sup>th</sup> and 25<sup>th</sup> BoG meetings vide Resolution Nos. 22.05, 24.05 and 24.06 respectively the institute proposed to permitted to issue notification for application by eligible faculty members and initiate the process by forming a committee with the Director in consultation with the Chairman, BoG by following applicable AICTE norms.

The agenda was presented before the members of the Board for kind consideration and approval. The members opined that as this matter is Institutional routine exercise, the same may be conducted as per rule.

Item No. 28.08: Proposal for extension of contractual teaching employees of CIT Kokrajhar till July 2023 or until the process of advertisement is over whichever is earlier.

> The Institute had appointed some faculty members on contract basis in various departments since their services were mandatory for the smooth running of academic curriculum and activities of the concerned departments. The Recruitment Rules (RR) and the Reservation



Roster Register (RRR) of the teaching staff are yet to be finalized. As the Mission Recruitment advertisement for Teaching will take some more time, it was proposed for extension of the Contract Faculty. he contract period of the following 06 (six) numbers of faculty members appointed in various departments be extended till the end of this academic session (i.e. 31<sup>st</sup> July 2023) to avoid disruption of smooth academic functioning or until the process of fresh contract advertisement is over whichever is earlier. This is being done keeping in view the earlier Resolution No. 27.10 of the 27<sup>th</sup> BoG Meeting.

Members were now informed that the process of advertisement for Mission Recruitment is underway and therefore until then they may be accorded extension until the completion of the academic session i.e. until July 2023.



However, the members were of the view that all process of Mission Recruitment should be handed on fast track mode, therefore they accorded their approval until 31<sup>st</sup> August 2023.

### Resolution: Proposed extension accorded until 31st August 2023.

Item No. 28.10: Proposal for creation of additional new posts against sanctioned strength for the non-teaching staff according to the ratio of "Faculty to Staff".

The institute was sanctioned 105 posts for the non-teaching staff under the Degree module. After upgradation to the Deemed to be University status, the ratio calculation following the "Faculty: Staff as 1: 1.1 (one is to one-point-one)" as per the AICTE/ MoE norms, it works out to be 117.

Calculations done may be noted as below.

The ratio of teaching to non-teaching is = 1: 1.1

Right now CIT Kokrajhar has 106 sanctioned teaching positions.

So required non-teaching posts will be =  $106 \times 1.1 = 116.6$ 

**ROUNDING OFF THE VALUE BECOMES 117** 

Members were apprised for the creation of 12 more additional sanction post owing to cater to the needs of "Post Graduate (PG) and PhD" programmes of the Institute.

Therefore, CIT Kokrajhar can expect to create 12 (twelve) additional sanctioned positions. As of now the following posts are mandated for smooth functioning of the institute. Once approved by members CIT Kokrajhar would prepare the RRs for further course of action.

Item No. 28.12: Approval for granting of "Sabbatical Leave" to Shri Ranjan Patowary, Assistant Professor, Department of Computer Science and Engineering (CSE) of the institute.

Shri Ranjan Patowary, Assistant Professor, Dept. of CSE had submitted an application dated 12<sup>th</sup> April 2023 for grant of sabbatical leave for a period of six (06) months (from 1<sup>st</sup> August 2023 to 31<sup>st</sup> January 2024) in the context of his PhD programme from the Indian Institute of Information Technology Guwahati (IIITG) under the guidance of Professor Gautam Barua, the Director and Professor of Dept. of CSE, IIIT Guwahati.

In accordance to Rule no. 23.C.1.a. the academic staff (Shri Ranjan Patowary) may be granted sabbatical leave "to conduct research or advanced studies in India or abroad" for a period not exceeding one (01) year and additional 120 days maximum if Board permits subject to the incumbent earning the same during his service.

The proposal for granting Sabbatical leave was discussed at length. The members noted the proposal and approved.

Resolution: The Sabbatical Leave to Sri Ranjan Patowary was noted and accorded approval by the members.

Item No. 28.13: Proposal for approval of the Revised Admission Regulations of the institute.

A proposal for "Revised Admission Regulations of CIT Kokrajhar" was placed in the 14<sup>th</sup> Senate Meeting. The members approved in principle the Academic-part of the Regulations vide Resolution No. 14.04 while the Financial-part of the Regulations was required to be placed in the 26<sup>th</sup> FC Meeting.

Consequent upon approvals/ recommendations of the i) Academic Regulations in the 14<sup>th</sup> Senate Meeting of CITK held on 18<sup>th</sup> April 2023 and the ii) Financial part of the Regulations in the 26<sup>th</sup> FC Meeting held on 6<sup>th</sup> June 2023, the members of the BoG were requested to kindly accord their approval for the "Revised Admission Regulations of the institute".

Upon discussions the members noted that the proposed remunerations were on a higher side. Therefore, recommended to continue with the existing remunerations. Further, Director's should be exempted from being provided with any remunerations.

Resolution: Members noted and approved the Revised Admission Regulations as per 26<sup>th</sup> FC Meeting Resolution no. 26.17.

Item No. 28.14: Proposal to convert two nos. of posts of Junior Engineer to two nos. of posts of Junior Technical Superintendent.

Central Institute of Technology Kokrajhar was sanctioned 04 (four) nos. of posts of Junior Engineer (two each for Electrical and Civil), by the MoE, Govt. of India vide letters

- i) F.No.24-2/2011-TS.VII, dated 04/05/2016 (placed at annexure 8.A),
- ii) F.No.24-2/2011-TS.VII, dated 23/04/2020 (placed at annexure -8.B) and as per the "Recruitment Rules" vide no. F.No.7-3/2020-TS.VII, dated 30/11/2021.

It was resolved in the 26<sup>th</sup> BoG Meeting dated 29.06.2022 vide Item No. 26.10 that "Engineering Cell of CIT Kokrajhar may execute Original and Repair works upto work value of ₹5.00 Lakh only".

Work value above ₹5.00 (five) lakh only are to be routed through the PWD/ CPWD and other govt. agencies for execution. Therefore, anticipating the minimization of the volume of future infrastructure work, the institute proposes to convert the 02 (two) posts of Junior Engineer (one each for Electrical and Civil) into 02 nos. of posts for Junior Technical Superintendent (JTS). Members may kindly note that all these posts have the same Grade Pay of ₹4200/-(Seventh CPC Pay Matrix Level: 6).

Upon discussions on the matter, Director (T) suggested to place a separate proposal to the MoE for conversion of the posts.

Resolution: Matter withdrawn.

Item No. 28.15: Proposal for approval of the "List of Subject Experts for Recruitment of Non-teaching Staff" in CIT Kokrajhar.

The list of subject experts had been prepared for direct recruitment of the non-teaching staff for CIT Kokrajhar. Members were requested for kind consideration and approval.

After discussion at length, the Board decided that the discretion for finalizing the expert list be with the Chairman BoG.

Resolution: List of Subject Experts for Recruitment of Non-teaching Staff" in CIT Kokrajhar is under discretion of the Chairman BoG.

Item No. 28.16: Proposal for "Age No Bar" for Institute's candidates both teaching/ non-teaching.

It is to appraise that the grant for relaxation for upper age limit for the direct recruitment in Teaching/ Non-Teaching positions of CIT was not mentioned in the Institute's RR (Recruitment Rules).

Therefore, the Institute proposed to considered "no age bar" for the internal candidates applying for the various positions under direct recruitment.

Members were therefore requested to considered for age no bar for the **internal candidates** of CIT Kokrajhar.

After threadbare discussions members concluded that Age relaxation upto five years would be provided to those internal candidates working on contract for five years or more. This relaxation would be one time exemption in the service period of the incumbent. The proposal for "Age No Bar "was therefore not accepted by the members.

Resolution: Members resolved the following.

- 1. Age relaxation upto five years for those internal candidates working on contract for five years or more.
- 2. The proposal for "Age No Bar" was not considered for approval.

Item No. 28.17: Proposal for the consideration of resignation of Dr. Sanjay Karmakar from the post of Assistant Registrar (Finance).

A representation has been received from Dr. Sanjay Karmakar to relieve him from his present services so that he can join new office as soon as possible.

In reference to file no. CIT/ KOK/ PF/ S. Karmakar/ 1581/ 2017/ 1029, dated 14-02-2023 approval through proper channel, Dr. Sanjay Karmakar had earlier applied for the post of Accounts Officer on Direct Recruitment basis at Indian Statistical Institute, Tezpur, Assam against the advertisement vide no. "REC-05/2022-2, KOL dated 14-05-2022". Accordingly, he has been selected for the same vide appointment letter no. "PU/ 103/ REC/ 07 dated 03-04-2023".

Subsequently, the institute has already received representation from Dr. Sanjay Karmakar in the form of technical resignation on 06-04-2023 for consideration and relaxation of notice period to relieve him to join the said new post at Indian Statistical Institute, Tezpur, Assam immediately. As his application was routed through proper channel and also in the aforesaid appointment letter he was instructed to join within 8<sup>th</sup> May 2023, his proposal for release was placed to be considered for relaxation notice period up to 2 months' time from the date of his resignation instead of 3 months so that he could join as soon as he completes 2 months' notice period at the institute.

The Board Members were requested to consider his notice period up to 2 months in this case and may kindly waive his notice period by one month or as the Board decides deemed fit.

The resignation was accepted by the members. The members advised the Institute to release Dr. Sanjay Karmakar as per terms and conditions of appointment.

Resolution: Noted and accepted for release as per terms and conditions of appointment.

Item No. 28.18: Proposal for opening a two (2) years Post-Graduate program i) M. Sc. in Data Science and ii) M. Sc. in Material Science.

A representation has been received from the department of Computer Science and Engineering (CSE) regarding opening of a two-year post-graduate M.Sc. programme in Data Science (within the department of CSE), which is designed to align with the National Education Policy 2020.

The aim of the programme would provide students with advanced knowledge and skills in the field of data science, which is becoming increasingly important in today's digital age. The program would equip students with the necessary tools and techniques to analyze and interpret large sets of data, enabling them to make data-driven decisions and contribute to various industries and sectors. The program holds significant potential in meeting the demands of the current job market and fulfilling the educational needs of aspiring data scientists. Its establishment would not only benefit the students but also contribute to the overall growth and reputation of CIT.

To support this request, the "Proposal for opening two (2) years Post-Graduate program M.Sc. in Data Science" document, which outlines the program's objectives, and anticipated outcomes was proposed. Additionally, the "Minutes of Meeting (MoM) - 11-05-2023" document for reference, providing a summary of the discussions and decisions made during the relevant departmental meeting was placed for approval.

The proposal for opening M.Sc. in Material Science was placed in the 14<sup>th</sup> Senate Meeting wherein the members considered and recommended for approval of the BoG.

The Members noted the proposal. However, accepted the recommendation of the 14<sup>th</sup> Senate to pursue the 2 years Post Graduation Program M.SC in Material Science. The M.SC program in Data Science is on hold subject to consideration and recommendations of the Senate.

Resolution: The Members Noted and accepted the proposal for starting the 2 years Post Graduation Program M. Sc. in Material Science.

Item No. 28.19: Ratification of General Information on Sponsored Research Projects and Consultancy Jobs of CIT Kokrajhar.

> The proposal on "General Information on Sponsored Research Projects and Consultancy Jobs" of CIT Kokrajhar was placed in 19th BoG as "Drafting Handbook on R&D Guidelines" in Reporting Items Agenda Item No. 19.9.3.

> As no comments were receive from the BoG members in the 20th BoG Meeting regarding this item, it was assumed to be confirmed.

> The title of agenda in 19th BoG refers to taking permission for drafting of the handbook, whereas, in the discussion it refers to the drafting of the handbook has already been completed by the R&D section of the Institute and is placed for approval. ### Additional Agenda Item No. 28.23:

Proposal for amendment of existing Recruitment Rules (RR) for the non-teaching posts.

The institute proposes to make necessary amendments in the Recruitment Rules (RR) for the following 2 nos. of posts.

### 1. Assistant Registrar:

In the RR of the non-teaching staff of CIT Kokrajhar notified vide MoE, GoI office order no. F.No.7-3/2020-TS.VII, dated 30<sup>th</sup> November 2021 the *minimum eligibility service* for promotion from Pay Matrix Level 10 (of 7<sup>th</sup> CPC) to Level 11 is given as **8 years**.

In this regard, it is to mention here that, as per the DoPT's Office Order vide no. F.No.AB-14017/4/2021-Estt.(RR), dated 20<sup>th</sup> September 2022 the revised norms for *minimum eligibility service* for promotion from Pay Matrix Level 10 (of 7<sup>th</sup> CPC) to Level 11 is 5 years.

In view of this, the institute proposes to adopt the norms notified vide the referred office order of the DoPT, GoI mentioned above and to amend the RR of the post of Assistant Registrar by revising the **minimum eligibility service** for promotion to **5 years**.
