Item No. 27.08:

Proposal to consider the Roster Reservation Register (RRR) of the non-teaching employees of CIT Kokrajhar.

As per the Resolution No. 26.17 of the 26th BoG Meeting held on 29th June 2022 in IIT Guwahati, it was instructed that CIT Kokrajhar circulate the RRR of the non-teaching employees of the Institute among the members of the Board before submitting the same to the MoE, Govt. of India (GoI) for concurrence.

The same was carried out by the Institute. The RRR was circulated to the members of the BoG. As no comments were received, it was later submitted to the MoE, GoI for concurrence. The MoE, GoI later instructed CIT Kokrajhar to place the same again before the members of the BoG for concurrence.

Thus, the Roster Reservation Register for the "non-teaching employees" of CIT Kokrajhar was again placed before the meeting. Members were requested to approve/ consider the same.

Resolution:

The RRR was approved by the members.

Item No. 27.09:

Proposal for adoption of AICTE / UGC norms for recruitment of faculty of CIT Kokrajhar.

CITK had framed its own Recruitment Rules (RR) for the teaching staff which was approved vide BoG Resolution no. 06.06 in the 6th (Sixth) Meeting of the BoG dated 7th October 2013. CITK now declared as Deemed to be University feels that AICTE notification vide F.No. 61-1/RIFD/7th CPC/2016-17, dated New Delhi, the 1st March, 2019 and UGC regulations vide No. F.1-2/2017 (EC/PS) dated New Delhi, the 18th July, 2018 must be followed for all future appointments of faculty positions. Members were requested to consider the proposal.

Resolution:

The members resolved that for recruitment of the faculty members the institute should have its own RR. A committee in this regard may be formed by the Director for preparing the RR. The new RR may be placed in the next BoG meeting for its approval.

Item No. 27.10:

Proposal for extension of contractual teaching employees of CIT Kokrajhar.

Item No. 27.13: Proposal for consideration of the statement of distribution of sanctioned posts.

As per the MoE, Govt. of India letter for the sanctioned posts of non-teaching staff of CIT Kokrajhar vide nos.

- i) F.No.24-2/2011-TS.VII, dated 04/05/2016,
- ii) F.No.24-2/2011-TS.VII, dated 23/04/2020 and as per the "Recruitment Rules" vide no. F.No.7-3/2020-TS.VII, dated 30/11/2021, the Institute is in a position to recruit against the sanctioned vacancy posts.

In this connection, it is to state that as per reports of the **Five Member Committee** for the preparation of **Reservation Roster Register (RRR)** for the non-teaching staff of CIT Kokrajhar, Sl. No. C.5 says that the **08 nos.** of positions/ posts of Multifunctional Assistant/ Data Entry Operator and Senior Assistant were sanctioned in 2016 while another **02 nos.** of positions of Multifunctional Assistant/ Data Entry operator were sanctioned in 2020.

The Recruitment Rules (RR) for Senior Assistant is available, but the RR for Multifunctional Assistant/ Data Entry Operator are not available.

Since the sanctioned post of the Institute did not indicate the numbers of positions to be earmarked for Multifunctional Assistant/ Data Entry Operator and Senior Assistant the Committee members were not in a position to prepare the roster for these positions/ posts.

In this regard, it was proposed to distribute the posts positions as follows.

Members were requested to consider as proposed and or advice on the same.

Resolution: The proposal was resolved and approved.

Item No. 27.14: Proposal for formation of Revised Medical Board of CITK.

The earlier Medical Board that was formed is now defunct. Now the Institute feels that the Medical Board needs to be reviewed. Hence, the following members in the new medical board were proposed.

CIT Kokrajhar feels that the functions of the Medical Board also need to be framed/ reframed. The revised Medical Board proposed, may also be tasked with framing/ reframing of the functions of the Medical Board as well.

Members were requested to consider and approve the revised Medical Board.

Resolution:

Members approved the revised Medical Board. However, it was suggested that in view of the recent administrative changes, instead of RNB Civil Hospital it needs to be read as Kokrajhar Medical College and in place of Mr. Haradhan Chel, a lady faculty member may be appointed as a member of the board.

Item No. 27.15: Proposal for outsourcing of man power requirements of CIT Kokrajhar.

The Board members were intimated about the dire requirement of the 167 nos. of outsourcing staff/ man-power (driver, security, housekeeping etc.) who are currently working in CIT Kokrajhar. A Housekeeping Staff Committee of the Institute had been looking into the needs and monitoring of the outsourcing staff.

The members were informed that the earlier contract for the outsourcing staff/ manpower requirements of CIT Kokrajhar had expired on date 15th April, 2022 and since then, it had been on extension. Thus, a proposal was placed for floating tender for the outsourcing of manpower requirements.

The members were also informed that the Institute planned to re-structure and place the personnel accordingly to its changing needs and requirements.

The Board was informed that the remunerations of the outsourcing staff/ personnel would be as per minimum wages circular published by Ministry of Labour & Employment, O/o the Chief Labour Commissioner (C), New Delhi, Govt. of India vide no. No. 1/16(5)/2021-LS-II, dated 8th July, 2022 and its subsequent modifications.

The Board members were requested to consider/ approve as proposed.

Resolution: The house considered and approved the requirements as proposed.
