#### Resolution No.1:-

The meeting unanimously confirmed the minutes of 4<sup>th</sup> Finance Committee meeting held on 10<sup>th</sup> July/2010 in the Conference Hall, NEHU Guest House, Borjhar, Guwahati.

#### Resolution No.2:-

The House approved the total expenditure incurred by the Institute amounting to Rs.26,82,82,823/- (Rupees Twenty-six crores eighty two lakhs eighty two thousand eight hundred twenty three) only out of the total fund received for Rs.27,81,57,892/- (Rupees Twenty-seven crores eighty one lakhs fifty seven thousand eight hundred ninety two) only and (Opening balance as on 01-04-2010 is Rs.1,70,32,423/-, received from MHRD, Govt. of India Rs.24,99,00,000/-,State Govt. Rs.9,92,220/- and IRGs and Bank interest is Rs.1,02,33,249/.) Closing balance remains as on 31-03-2011 is for Rs.98,75,069/-. Hence expenditure for Rs.26,82,82,823/-is accepted and is to be placed before the BoG for approval for placing in the C&AG Audit for the financial year 2010-11.

#### Resolution No.5:-

The Finance Committee accepted the proposal for connecting Town Feeder Power Supply to the CIT, Kokrajhar for Rs.71,00,000.00 as per estimate submitted by APDCL for executing this matter for meeting acute power shortage and decided to execute the work at an early date. The Hon'ble Members of FC recommended the matter to BoG for approval.

### Resolution No.6:-

The Hon'ble Members of the Committee decided to authorize Registrar cum Finance Officer as a signatory for NPS related work.

#### Resolution No.7:-

The Hon'ble Members of the Committee decided and directed the Institute to utilize the IRG earning by the Institute for the activities like Plantation, Seminar, Special Classes, Education Tour, Calling leading figures in the different fields to the Institutes. Proposal is to be made to the Ministry of HRD for matching grants on IRG of CIT Kokrajhar to be claimed from GOI.
