Item No: 14.01 Confirmation of the Minutes of the 13th Finance Committee Meeting on 22nd May 2017 at 10:30 A.M. in CIT, Kokrajhar.

The Minutes of the 13th (thirteenth) Finance Committee (FC) Meeting of CIT Kokrajhar held on 22nd May2017 at 10:30 A.M. in the Conference Hall, Guest House of CIT Kokrajhar, was circulated to the members of the FC, CIT Kokrajhar.

Item No: 14.03:

Proposal to consider and approve the annual accounts CIT Kokrajhar for the 2016-17 as audited by the C&AG, Kolkata.

As per resolution no 13.03 of the 13th MOM of FC meeting, C&AG, Kolkata was invited to take up the audit of the annual accounts for the FY 2016-17. Accordingly, audit team from Guwahatioffice took up the audit from 05-10-2017 at CIT, Kokrajhar. C&AG audit team submitted draft audit report on 17-10-2017 and CIT Kokrajhar submitted para wise comments on 24-11-2017.

We have already received Separate Audit Report for the FY 2016-17 on 03.01.2018 from Director General Audit, Central, Kolkata.

The members discussed the annual statement for the financial year 2016-17 and recommended for approval from the BOG and to be placed before both the houses of the parliament.

Annual statement of accounts and separate Audit Report now placed before the Finance Committee for approval. After approval by FC and BOG, this will be forwarded to the MHRD, placed at *Annexure – III* (page:8to 8).

Members were requested to consider and recommend for approval.

<u>RESOLUTION</u>: Separate Audit report of C&AG on the accounts of 2016-17 has been discussed. As there was no major issue on the presentation of the accounts, the members approved the same and recommended for BOG's approval.

Item No: 14.04:

Proposal to consider the recommendation of meeting of the 20^{th} BWC of CIT.

CIThas initiated various construction activities for the FY 2017-18. Accordingly, 20thBWC meeting was held on 08/01/2018. Recommendation of the members mentioned in MOM of the meeting is placed for approval of the FC.

Members are requested to consider and recommend for approval.

RESOLUTION: The members gone through the minutes and was approved.

Item No: 14.05:

Implementation of report on 7Th Pay Commission.

We have received the report of 7th CPC for revision of pay of faculty and scientific design staffs vide order F No.15-4/2017-TC Govt of India, MHRD, Department of Higher Education dated 27/10/2017.

Similarly, we have received the report of 7th CPC for revision of pay of non-teaching staff vide order no Fno.15-1/2017-TC (Vol-II) Govt of India, MHRD, Department of Higher Education dated 29/12/2017.

Both the reports were being placed in the FC for adoption and implementation.

RESOLUTION: The members had gone through the recommendations. They approved the recommendations provided for teaching, Non-teaching, re-employed and contractually employed staff.

Item No.14.06:

Proposal for Funding Gratuity of Employees covered under NPS with CAP Assurance Scheme of SBI Life.

Actuarial valuation had already been done as on 7/4/2017 for Rs. 1,03,75,439/-. It had been observed that SBI Life has been providing higher rate of interest compared to LICI. A comparative statement of the interest was declared since inception. It was also proposed that, on approval, the gratuity will be funded by way of investment, so that at the time of super annuation of employees this fund can be utilised for payment of gratuity. The members suggested that, the proposal for payment of gratuity to the employees should be forwarded to the ministry of HRD for funding instead of using the fund generated by the institute through IRG.

RESOLUTION: The proposal for the gratuity to be forwarded to the MHRD for approval.

Item No.14.07:

Sitting Fees for External Members to attend meetings of Society, Board and other committees

As per Rules of the Institute, the external members are nominated to serve as members of Society, Board of Governors and other committees. The Institute pays a nominal amount of Rs. 3000/- as sitting fee to the external members (in addition to taking care of their boarding/lodging and travel) which needs upward revision. Reason for delay in placement of Audited Annual Accounts.

The annual statement of accounts for the FY 2016-17 of Central Institute of Technology, Kokrajhar is approved by the BOG to invite C&AG, Kolkata to take up the audit for the 2016-17.

Accordingly, Director of General of Audit Kolkata was requested through the mail on 23-05-2016 to take up the audit exercise at the earliest.

On 14-06-2017, Audit intimation was received from Director Branch Office Guwahati that audit work is resumed from 03-07-2017.On 20-06-2017 Deputy Director Inspection intimated vide letter that audit will not be taken up unless the accounts of CIT Kokrajhar is entrusted with C&AG of India as the period of entrustment is over in the FY 2015-16 (as the entrustment was given for auditing up to the FY 2015-16)

Accordingly on 21-06-2017, Director Branch Office Guwahati intimated the deferment of Audit until the audit on accounts of CIT Kokrajhar is re-entrusted to C&AG of India.

On 28-08-2017, Undersecretary to the Government of Indiaintimated that consent of C&AG India has been received for a period of five years from 2016-17 to 2020-21 and finally the audit team from Guwahati Office took up the audit from 05-10-2017.
