i)Principal and interest amount of HEFA funding will be borne by the MHRD. Government of India.

ii)All kinds of ongoing construction activities of the institute like constructions of the SC/ST Girls Hostel, constructions of the Academic Block and constructions of the Auditorium which are pending for several years need to be completed immediately. Any further construction (other than girls hostel and one floor of the academic block) can be considered only after CIT presents the status of current construction in progress both under OH-35 and under HEFA.

The MHRD agreed that it will fund the ongoing construction activities which are pending and at the same it has also advised the members that the authority of the CIT Kokrajhar should send the proposal to the NEC through Assam Government for additional funding requirements of the construction activities of the institute.

Item No. 19.04:

Proposal for Funding Gratuity of Regular employees of CIT Kokrajhar covered under NPS:

LIC, Divisional Office, Guwahati has offered a proposal for gratuity related work of our institute. Since, LIC is a fully government owned organization and has huge experience in this field of Pension and Gratuity and also it has been handling same kind of work for Assam Engineering College. Guwahati and other premier institute of northeast India, hence the said work may be entrusted upon them.

Moreover, they have provided us the service of actuarial valuation of the gratuity of all regular employees at free of cost and also, they will provide life risk cover for all employees of the institute. Additionally, they will also provide us the annual return on investment of the gratuity funds @7.7% to be maintained with them year to year basis.
