Interested parties/eligible and competent Service Providers/ Building owners/Agencies, meeting the eligibility criteria as per EOI document may submit their offer in prescribed application form under two bid systems.

Expression of Interest (EOI) is invited for providing premises for accommodation of 200 students (100 Boys + 100 Girls) of CIT Kokrajhar, Assam along with quoted rate as per the requirements given below-

The premises shall preferably be within 10 kms. radius from CIT Kokrajhar, Assam.

- 2. The premises shall be under exclusive and dedicated usage of CIT Kokrajhar and no other guests may be permitted. In case of big/large premises having capacity of accommodation of 100 students only one premise will be hired, otherwise two small premises for accommodation of 50 students in each hostel will be hired as stated in Para (1) above.
- 3. The Agency or party should have full ownership of the premises for the said purpose.
- 4. The lease agreement initially shall be for a period of one year as per need & may be extended further for another two years within the terms and conditions as per the original agreement.
- 5. The Agency or party shall provide the details of the contact person who will be the single point coordinator and responsible for all obligations.
- 6. A clause of termination of the contract with one month's notice without assigning any reason from CITK side shall be incorporated in the agreement.
- 7. Applicable GST shall be also paid subject to providing required documentation as per GST Law. Other rate, rent, taxes & cess levied by Govt./Local authorities will be paid by the land owner.
- 8. The agency or party shall give free access to the licensor and their representatives to enter into the premises at all times. Parking of vehicle/School Bus in the parking & space of the Hostel Premises will be free of cost & including of the monthly rent.
- 9. The agency or party must keep the premises and drainage/ sewage lines etc. in good working conditions.
- 10. If at any time during tenure of the license, the premises are affected/destroyed/damaged on account of natural calamities, or otherwise, the agency is to get them repaired/replaced immediately at their own cost.
- 11. Each room size should not be smaller than 10'x 12' (excluding the area of attached toilet) and shall accommodate two or three students as required in a room.
- 12. All the rooms shall be equipped with good electrification facilities like switch board, fan etc. and the minimum requirement of furniture and fixtures, wall rack, etc. required for the Students.
- 13. The hired buildings must have attached toilet-cum-bathroom facilities, preferably in each room.
- 14. 24/7 uninterrupted water and power supply should be available to the rooms and premises as required. In case of Power Shut Down, alternate arrangement/Generator Service shall be made available by the land/building owner.
- 15. The hired buildings must be surrounded by concrete boundary walls for security purpose.

The individuals/agencies financially sound and capable of meeting the requirements broadly as aforesaid but not limited to only those, may express their interest with their profile, building details, experience (if any), and the time limit by which they can make the facility ready for occupation. EOI for Hostel for accommodation of 100 students in a Single Building Premises (Hostel-A/C') or two Hostels for the accommodation for 50 nos. of students (Hostel-B/D') in each is to be submitted separately in Separate Envelopes at the time of submitting their bids.

EOI to be submitted in Separate envelopes for Boys' and Girls' Hostels.

However, CITK reserves the right to accept or reject any expression of interest in full or partial and also to receive any subsequent expression of interest beyond the due date.

- ➤ Canvassing in any form and / or bringing any influence, political or otherwise will be treated as a disqualification and their expression of interest shall be summarily rejected;
- ➤ The Institute reserves the right to rectify any discrepancy of the Advertisement, if found later on:
- Applicant shall be responsible for the correctness of the information provided in the Expression of Interest. If it is found at a later date that any information given in the Expression of Interest or thereafter is incorrect/ false, their expression of interest not only shall be rejected but also the agency shall be blacklisted for future; forfeiting the deposits/ bank guarantee placed;
- The monthly payment of rent shall be subject to deduction of taxes as per rule (TDS).
- ➤ The charges for electricity consumption will be payable as per terms & condition of the agreement between the two parties.
- ➤ The CITK shall have the right to make temporary renovation partition and installation of furniture and fixture as per requirement of the students/institute living/residing in the Hostel.
- ➤ CITK will not be responsible for non-receipt of Expression of Interest within the stipulated date or postal/ transit delays and documents not attached/ incomplete.
- Expression of interest received through brokers/agents shall be outrightly rejected;
- > CITK reserves the right to accept or reject any or all the Expression of Interest received without assigning any reason. The decision of CITK shall be final and binding.
- Any dispute with regard to the selection/ acceptance shall be subject to Kokrajhar District Jurisdiction, Assam only.
- ➤ Any local disturbance/police case etc. not related to students will be tackled by land owner.
- ➤ Inspection/Visit of location CITK authority shall have the right to inspect the locations/premises to check the suitability of the premises for accommodation as students Hostel along with technical criteria as per –ANNEXURE-A1 & A2, before acceptance of the Technical Bid.

- i. Price Bid for Boys' Hostel and Girls' Hostel for accommodation of 100 students & 50 students shall be submitted separately in separate Envelopes.
- ii. Rate of the single premises with the capacity of 100 students will be compared with the aggregate rate of rent of other two small premises capacity of 50 students in each, subject to other terms & conditions, area, location etc.
- iii. Financial Evaluation will be alone on the basis of comparative statement prepared separately in case of Hostel for accommodation of 100 students & 50 students accordingly and vice versa to get the minimum reasonable rate of rent for 100 beds.
- iv. If the offered rate of the Hostel per 100 students in a single premise becomes much higher than the aggregate offered rate of two hostels, then CITK authority will be free to accept the L1 rate of two separate small Hostels as per price Preferences.
- v. If the two bidders of small premises (50 students) become different land owners than the L2 & L3 will be negotiated to accept the rate offered by the L1 bidder, subject to consideration of the area, location and prevalent market rate of rent for different premises. The decision of the CITK authority will be final.
